#### 1. Background/Introduction

Colby Community College is located in the northwest corner of Kansas, approximately 50 miles from the Colorado and Nebraska borders. The area is part of the High Plains, sweeping upward to the Rocky Mountains 250 miles to the west.

#### 5. Timeline

The initial contract period will be from the date of the award, officially October 15, 2018 through June 30, 2021, with the option to renew for one year at a time for up to two years unless either side opts to terminate the agreement.

# **6.** Elements of Proposal

A submission must, at a minimum, include the following elements:



- Description of the products and services included in the agreement.
- Description of pricing method for products & services including any discounts, promotions, and incentives provided.
- Additional benefits that may be provided such as team stores, advertising, sign on bonus, or other items (those items listed provided as examples only and are not intended to be all encompassing)
- Sales representative information including how the sales representative(s) will provide service to Colby Community College including but not limited to information on the ability embellish items such as screen printing or embroidery.
- Information detailing any termination clause
