# 1. Background/Introduction

Colby Community College is located in the northwest corner of Kansas, approximately 50 miles from the Colorado and Nebraska borders. The area is part of the High Plains, sweeping upward to the Rocky Mountains 250 miles to the west.

Colby Community College offers a variety of one and two-year degree and transfer programs. From its humble beginning in 1964, which consisted of makeshift classrooms in downtown buildings, the college has blossomed into a dynamic institution of more than 2,200 students. In addition to an 80-acre main campus, CCC operates a 60-acre farm for students to use as a hands-on laboratory and training facility. A pioneer in outreach education, CCC accommodates hundreds of off-campus students by offering classes in the 14-county service area and around the globe through ColbyConnect.

Athletically, Colby is a member of the NJCAA and competes as a member of the national recognized Kansas Jayhawk Community College Conference. The Trojans boast 3 NJCAA National Championships, 28 Region 6 Championships, and 16 Conference titles.

# **Purpose:**

Colby Community College is seeking to enter into a multi-year agreement with a qualified and experienced local athletic, apparel, footwear, and uniform dealer to procure a full range of sports uniforms, and related apparel and shoes from one manufacturer for all teams at the CCC Department of Athletics on an as-needed basis.

# **Project Timeline:**

The following is the schedule that applies to this RFP. But may change in accordance with the organization's needs or unforeseen circumstances.

- Request for RFP: May 22nd, 2023
- Due date for proposals: June 9, 2023
- Selection of Vendor: June 19th, 2023

The initial contract period will be from the date of the award, officially June 19th, 2023 through June 30, 2026 with the option to renew for one year at a time for up to two years unless either side opts to terminate the agreement.

# **Elements of the Proposal:**

Colby Community College is seeking the following features in an athletic apparel provider:

A submission must, at a minimum, include the following elements:

• Description of the products and services included in the agreement.

• Description of pricing method for products & services including any discounts, promotions, and incentives provided.

• Additional benefits that may be provided such as team stores, advertising, sign on bonus, or other items (those items listed provided as examples only and are not intended to be all encompassing)

• Sales representative information including how the sales representative(s) will provide service to Colby Community College including but not limited to information on the ability embellish items such as screen printing or embroidery.

• Information detailing any termination clause

- Late responses will not be accepted and will be returned to the submitting company unopened.
- The college is not liable for any cost incurred by any person or firm responding to this RFP.
- Additionally the College reserves the right to reject as non-responsive any proposals which are not organized and formatted as described in this RFP.
