# I. CALL TO ORDER

The regular meeting of the Board of Trustees of Colby Community College, Thomas County, Kansas, was held in Thomas Hall on Monday, September 18, 2023, at 5:00 p.m.

Sloane Enninga from the Colby Free Press joined via Zoom at 5:03 p.m. Doug Johnson recorded the minutes.

## III. APPROVAL OF THE CONSENT AGENDA

Jessica Vaughn moved to accept the consent agenda that included the August 21, 2023, meeting minutes, employee contracts, and Resolution No. 2, as presented in the finance packet. The motion was seconded by Patrick Toth and passed 6-0.

# IV. BUSINESS

### A. Old Business

No new business was brought before the Board.

## B. Annual Report (Discussion)

Trustees reviewed the 2022-23 Annual Report, a publication that chronicles highlights of the College's achievements and provides financial data from the academic year.

# C. Colby Commitment Scholarship (Discussion)

President Carter proposed offering a tuition and books scholarship to students in the College's service area who are on free and reduced lunches. He will collect more information and report to the Trustees at a future meeting.

## D. Disposition of Surplus

Trustees reviewed a list of items from the Veterinary Nursing department that are

broken or nonfunctional. Jessica Vaughn made a motion to dispose of the presented items, which Donna Henry seconded. It passed 6-0.

# E. Federal Payment Policy

President Carter presented a policy required to comply with the Code of Federal Regulation so the College is eligible to receive the Congressionally Directed Spending Request.

Donna Henry made a motion to approve the Federal Payment Policy, which Arlen Leiker seconded. It passed 6-0.

## F. Legal Assistance Fund-KASB

Trustees review the agreement between Colby Community College and the Kansas Association of School Boards to provide legal assistance at \$2,750 per year (July 1, 2023-June 30, 2024).

Arlen Leiker seconded a motion by Patrick Toth to approve the Legal Assistance Fund. The motion passed 6-0.

# G. NW Kansas Educational Service Center Head Start/Early Head Start MOA

The agreement with the NWKSESC Head Start/Early Start program and Colby Community College provides the Trauma Informed program at a rate of \$50 per credit hour. The annual agreement will be revised before the 2024-25 academic year. The tuition difference is funded through the Workforce Training Funds from the state. Dr. Carter noted the agreement strengthens the College's relationship with the Service Center and allows more individuals to access the program. Currently, the USDs receive free training because of Project EVERS (individuals not in K-12 education are not eligible for Project EVERS monies).

A motion by Arlen Leiker was seconded by Donna Henry to approve the agreement with the NWKSESC Head Start/Early Start program and CCC. The motion passed 6-0.

# H. Policy Review: Accessibility, DLVNP Rabies, and Condolences and Other Recognition Policy

The following policies were reviewed: Accessibility, DLVNP Rabies, and Condolences and Other Recognition.

Arlen Leiker moved to update or review the policies. He was seconded by Patrick Toth. The motion passed 6-0.

Assistant Wrestling Coach Quentin Pauda resigned to pursue other opportunities.

A motion was made by Donna Henry to accept the resignation, and Jessica Vaughn

seconded the motion. The motion passed 6-0.

## J. Executive Session

At 5:30 p.m., Chair Flanagin made a motion to enter into a 20-minute executive session with the Board and President Carter. Arlen Leiker seconded the motion, which passed 6-0.

At 5:50 p.m., Trustees returned to an open session. Quintin Flanagin moved to terminate custodian Ruby Shirley and was seconded by Audrey Hines. The motion passed 6-0.

# V. <u>Foundation Update</u>

Melissa Rickford said the annual auction grossed a little over \$110,000, with the net total appearing to be more than in 2022. The Foundation board is discussing what time of year to have the auction in 2024. A former student donated a painting to the Foundation in early September.

## 2. Tiffany Evans, Academic Affairs

Vice President Evans thanked everyone involved with the college rodeo on Sept. 15-17 and appreciated seeing so many athletic teams and student organizations work together with the community. Dr. Evans praised the collaboration among faculty on various projects. The College was currently implementing Civitas, an analytics system to advise students.

## 3. Sheri Knight, Business Affairs

Vice President Knight thanked the staff in the Business Office and other areas on campus who helped with the rodeo. She asked for two Trustees to join the Finance Committee. Audrey Hines and Donna Henry volunteered to serve on the committee in the fourth quarter.

### 4. Doug Johnson, Public Relations

Three new promotional videos have been produced and will be circulated for various marketing campaigns.

## 5. Kenny Hernandez, Athletics

Director Hernandez said the success of the rodeo was a complete community effort. The volleyball team was having a "pink-out" on Sept. 20. Baseball and softball teams have started their fall seasons. The men's and women's cross country teams won the junior college divisions at their first meet. The winter sports seasons begin on Oct. 1. The Student-Athlete Advisory Committee (SAAC) has been formed, and officers have been

Dr. Carter said the College is volunteering at the Colby After School Program three out of four afternoons each week. Congressional funding has been approved, and the College will issue several RFPs in the coming weeks.

Audrey Hines enjoyed the rodeo and appreciates the positive energy from the College employees. Patrick Toth praised the courses offered at the Norton Correctional Facility and helping the inmates. Quintin Flanagan said he enjoyed the rodeo and the business it brings to the community.
