# A. PUBLIC HEARING OF THE 2019-2020 BUDGET

Kenton Krehbiel opened the public hearing at 7:04 a.m. Mr. John Kerns, Thomas County resident, addressed the board of trustees with his concern that an increase in the college budget will increase property taxes. Mr. Kern stated that his property taxes had increased 329.27 percent since 2012 but did acknowledge it was not all due to the college. Mr. Kern would like the college to cut smaller items from the budget so that no increase would be needed. Since there were no other comments, the public hearing was closed at 7:08 a.m.

#### B. ACTION ITEM ON INSTITUTIONAL BUDGET

Carolyn Armstrong made a motion to approve the 2019-2020 budget as published in the paper. Kenton Krehbiel seconded the motion. The trustees took a roll-call vote. Audrey Hines and Linda Vaughn voted "no" with Quintin Flanagin, Arlen Leiker, Kenton Krehbiel and Carolyn Armstrong voting "yes." The budget was approved with a 4 to 2 vote.
